

# MEG-A-THERM COBRA

## "THE LIQUID SNAKE" DRAIN OPENER and MAINTAINER

## TECHNICAL DATA

### GENERAL DESCRIPTION

COBRA Meg-A-Therm is a powerful, professional drain solvent designed to dissolve all organic obstructions on contact.

### AREAS OF APPLICATION

In commercial kitchens, apartment complexes, industrial plants, hotels and motels, schools, food processing plants, etc.

### SPECIAL FEATURES

**Opens Clogged Drains Fast** - Goes to work immediately to dissolve common organic stoppages such as grease, sanitary napkins, coffee grounds, soap, paper, cloths, lint, cigarette butts and petroleum greases. Foreign material not dissolved are released once the organic "binders" are dissolved by COBRA Meg-A-Therm.

**Restores Shrinking Drain Pipe Diameter** - Drain pipes build grease deposits, soap films, soft scale, slime and lose their efficiency. Drain pipes can become slow or actually stop. Regular applications of COBRA Meg-A-Therm removes these deposits and eliminates the shrinkage in traps, cross pipes, elbows and other areas near the drain openings.

**Will Not Harm Pipes** - Unique solvent action works only on organic matter. Will not deteriorate copper, steel, PVC pipes and fittings or rubber hardware within the system. Will not affect septic tank operation. COBRA Meg-A-Therm is neutralized when mixed with large volumes of drain water.

**Flashback is Eliminated** - Gradual, controlled activation of solvents reduce the risk of dangerous explosive reaction or flashback.

**Concentrated Power** - COBRA Meg-A-Therm's ingredients weigh twice as much as water and this weight carries the product to the source of stoppage with little loss of effectiveness.

### USE DIRECTIONS

1. Remove excess water from sink, drain or toilet.
2. Slowly pour 4-8 oz. (120-240 mL) COBRA Meg-A-Therm directly into drain.
3. **SINK DRAINS:** Let stand for 10 minutes. Flush with large quantity of water. Repeat if necessary.  
**FLOOR DRAINS:** Use about 8 oz. (240 mL) of contents and follow directions as above.
4. **PREVENTATIVE MAINTENANCE:** Use about 3 oz. (90 mL) regularly to prevent future blockages.

Remove excess water from sink, drain or toilet before use. Do not pour into standing water. Do not use on aluminum or galvanized material. Use with adequate ventilation.

**NOTE:** Where drain fails to open due to blockage by glass, plastic, iron or other inorganic material, use great caution when inserting mechanical cleaning devices. COBRA Meg-A-Therm remains active until it has been thoroughly diluted with large quantities of water. Rinse off equipment thoroughly with water after opening drain.

**DANGER: POISON. KEEP OUT OF REACH OF CHILDREN.** Contains sulphuric acid. Causes severe burns. Avoid contact with skin, eyes or clothing. Wash hands or any other area thoroughly if exposed to the concentrated liquid or diluted product.
